BEAVERTOWN BOROUGH ORDINANCES WITH PENALTIES

For all of the following ordinances, <u>if convicted</u>, the fine will be \$75.00 for a first offense and \$150.00 for the second or subsequent offenses:

- 1. Ordinance #15A-Weeds and Grass-If your property is not free of obnoxious weeds, or excessively high grass you will be in violation of an ordinance.
- 2. Ordinance #16-Garbage-dumping of garbage or on private property or Borough roads and streets is a violation of this ordinance (see Section #1).
- 3. Ordinance #31- Parking zones on Market Street extending 60'East and 60' West- of the center line of Sassafras Street is hereby declared to be a limited parking zone.
- 4. Ordinance 43-Willful disturbance of the peace by any loud, boisterous or unseemly loud noise or disturbance causing annoyance to nearby residents, or any public highway or street, or to the traveling public is considered to be disorderly conduct.
- 5. Ordinance 44: Establishes a curfew for children under the age of 18 years. Curfew hours are 11:00 p.m.-6:00 A.M. This ordinance exempts school activities, emergency errands and children going or coming from their place of employment. Children out during these hours accompanied by an adult are also exempt.
- 6. Ordinance #46: Curfew for the month of October only. Children shall not be on the streets after 9:00 p.m. except for Oct. 30th & 31st. Exemptions are children accompanied by an adult, on emergency errands, going or coming from employment, going or coming home from school or religious functions.
- 7. Ordinance #84-1: Prohibits parking of vehicles on the West side of Sassafras St. between Market St. and Chestnut St. within the Borough.
- 8. Ordinance #85-1-A: The speed limit was reduced from 35mph to 25 mph on all Borough streets; authorizes enforcement of this ordinance by Borough police authorizes the use of speed check devices and traffic control devices.
- 9. Ordinance #85-2- Requires issuance of driveway permits by the Boroughpermit fee is \$5.00.
- 10. Ordinance 02-07: Ordinance providing for burning of sylvan materials only, burning restricted to Tuesdays and Fridays.

For the following Ordinances, a minimum fine of \$100.00 shall be imposed, if convicted.

- 1. Ordinance #92-4: Requires and regulates the numbering of buildings
 2. Ordinance #92-6: Requires connection to and use of the Borough's water system. Requirements for lead free installation materials providing for changes for service s and adoption of rules and regulations and penalties for violation of the ordinance.
- 3. Ordinance #03-06: Ordinance prohibiting the use of break retarders in certain portions of Beavertown Borough and declaring them a nuisance; establishing penalties for violation of the ordinance and exempting use in an emergency situation. Current Fines \$100.00-\$300.00.
