**MINUTES, BILLS and TREASURERS REPORT:** Brian motioned to approve the March minutes and the emergency March minutes; Will second, with a roll call vote-unanimous yes-motion carried. Will motioned to approve April and May bills; Linda second, with a roll call vote-unanimous yes-motion carried. Ron motioned to approve the treasurer's reports for April and May; Will second, with a roll call vote-unanimous yes-motion carried.
