Beavertown Borough Council met on August 4, 2020

MINUTES, BILLS and TREASURERS REPORT: Will motioned to approve the minutes; Ron second, with a roll call vote-unanimous yes-motion carried. Lori motioned to approve the bills; Linda second, with a roll call vote-unanimous yes-motion carried. No Treasurer's report due to an early meeting.

Since there will be no Hillbilly Fever Days this year due to COVID 19, there will only be food stands open at the carnival grounds. The Revitalization Committee will be having a Community Yard Sale in October and a Christmas Light contest this year. Mayor asked Council since there are so many incidents in Beavertown at this time, if need can the Middleburg Police Department be allowed to go over 31 hours a month? Lucas motioned to allow Middleburg Police Department more hours when needed; Brian second, with a roll call vote-unanimous yes-motion carried.

BOROUGH SUPERVISOR'S REPORT: Phil took the Council on a tour of the Borough Building, showing how much of this building the Borough actually uses and how much every other organization that uses the building has in use. He also pointed out chairs and tables that are not needed. He needs things cleaned out to be able to put a/c units away and also easy access to the voting booths. All street lights are now LED. The 2020 road work has been completed. The burn ban has been lifted. The dusk to dawn signs for the playground, have been ordered.
