Beavertown Borough Council met on Tuesday, March 10th, 2020

MINUTES, BILLS and TREASURERS REPORT: Will motioned to approve the minutes; Denny second, with a roll call vote-unanimous yes-motion carried. Denny motioned to approve the treasurer's report; Ron second, with a roll call vote-unanimous yes-motion carried.

If there are any other streets that the Council feels need work, please let Phil know. There is going to be a sale on May 9th, 2020, Phil is asking for a Proclamation to close South Thomas St., from 522 to Cara St; this will be brought to the attention of Mayor Hollenbach. Phil spoke to PPL about the new street light in the Hahn Development and found out that all of the old street lights now qualify to be changed to led lights; he will start the process to have them changed.
